Important Update: SNA National Member Dues Increase Effective October 1, 2018

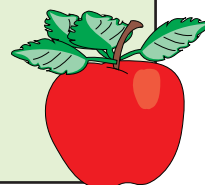
The SNA Board of Directors recently approved an increase in national member dues, which goes into effect on October 1, 2018.

2018 Champion of School Breakfast Award Goes to Wellston City Schools



Wellston City Schools received the Ohio School Breakfast Challenge (OSBC), "2018 Champion of School Breakfast Award." Ten 2018 School Breakfast Champion Award Winners and their local school administration were celebrated at the OSBC Spring Stakeholder Meeting, comprised of OSBC Partners, State School Education Associations and Education and

Health Supporters. Paolo DeMaria, Superintendent of Public Instruction, Ohio Department of Education, presented opening remarks to celebrate the "Champion Award Winners, School Breakfast Program Best Practices."

Award Winners received an engraved "Breakfast Bowl" for recognition of their collaborative and innovative school breakfast best practice.

The Champion of School Breakfast Award

Schools receiving the Champion of School Breakfast Award demonstrated collaboration between school administration, teachers, child nutrition and other building support personnel to enhance or expand access and student participation in breakfast at their school. Collaboration is a best practice and each Champion school demonstrated the positive impact that breakfast has on their student's academic day and behavior. Better attendance, less tardies, more calm students, less behavior issues, and less visits to the school nurse for the 10:30 hunger bug!

Wellston City Schools, Champion Award Winner exceeded expectations! As a result of collaboration between Food Service Director, Tina King and the Building Principals (Mrs. Eberts, Mrs. Lanning, Ms. Cupp, Mrs. Sowers) breakfast participation

increased, and students are better prepared to learn.

Mrs. King stated, "The main goal was to make breakfast accessible to All students. Each building principal collaborated with food service to design a breakfast strategy tailored to meet their needs. At the elementary schools, the principals designed a plan to dismiss students by grade level so students eat breakfast together every day. Breakfast participation at the elementary/intermediate buildings averages 95%, most of the remaining 5% is due to absences. At the middle/high schools, cold foods were moved to the hallways where the students can pick up a grab-n-go breakfast and eat in their classroom. In addition, if students want a hot breakfast they can go to the cafeteria to eat breakfast. At all school buildings students are offered a second chance for Breakfast After the Bell if they miss breakfast or are hungry later in the morning."

Implementing multiple serving strategies that are tailored for each building has led to a 30% increase in breakfast participation which in turn has increased revenue to purchase additional items for breakfast service. The next step is to purchase warmers so students can get hot breakfast items in the hallways. Students rarely visit the nurse's office due to hunger and start their day ready to learn!

Thank you for your outstanding collaborative efforts so all students have the opportunity to start their day with school breakfast.

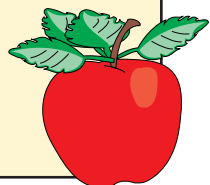

Wellston City Schools Receive Grant to Implement 'Grab and Go' Breakfast

The Wellston City School (WCS) District was awarded a "Breakfast in the Classroom" (BIC) Grant this year, that helps provide items to implement a "grab and go" style breakfast.

"The grant provides anything we need to help implement breakfast minus food," explained WCS Food Service Director Tina King. "So, it helps serve breakfast in the halls, or grab and go for the classrooms to reach out to students that are late arriving or just want something quick to not come through the line in the cafeteria."

King added, "We have had breakfast in the schools forever. The breakfast grant became possible this year. It started at the beginning of the school year. The grant lets us buy carts, tables, plates, napkins, etc. — just any equipment or supplies, no food."

On Friday, March 9, the school district hosted a "media day" and invited the local press, school board members, and other representatives. The media day was held in conjunction with National School Breakfast Week, which ran March 5-9.

Attending the event were Wellston City Schools Superintendent Karen Boch, Wellston City Schools Board of Education President Terry Gill, Wellston City Schools Board Vice President Gretchen Crabtree, school board member Betty Jenkins, Wellston Teacher Association (WTA) President Belinda Dixon, Wellston High School Principal Megan Sowers, WCS Food Service Director Tina King, State Representative Ryan Smith (R-District 93), Children's Hunger Alliance CEO Judy Mobley, Heather Loughley, Katy Sulfridge, and Scott Neely all with Children's Hunger Alliance; Ohio Education Association Vice President Scott Dimauro; and Makia Burns with the Ohio Education Association.

Wellston was selected based on the number of students who qualify for free or reduced-priced meals, average

daily participation in the school breakfast program, and district- and school-level support.

Wellston currently offers free breakfast to all students but is launching the campaign in the high school.

Next year, Wellston will see both its middle school and high school participating in the program.

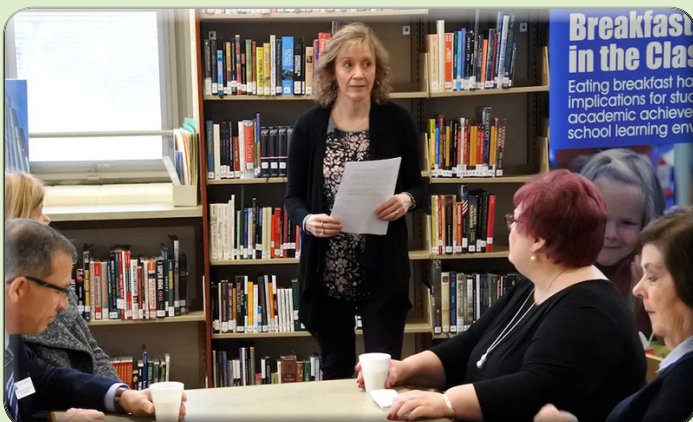
In September 2017, the grant funding was introduced to Wellston City Schools Superintendent Karen Boch and Food Service Director Tina King by Ohio Children's Hunger Alliance SNN Director Sonja Hill. Hill and King worked together on the grant application and submitted it to the Partners for Breakfast in the Classroom. Hill met with administration, cooks and support staff prior to submitting the application.

Wellston was selected to participate in the Partners for Breakfast in the Classroom program, which is a joint initiative from the Food Research and Action Center (FRAC), National Association of Elementary School Principals Foundation (NAESPF), the School Nutrition Foundation (SNF), and The NEA Foundation — collectively known as the Partners for Breakfast in the Classroom.

The program reworks how school breakfast is delivered by offering it to all students and moving it from the cafeteria to the classroom as a "grab and go" in an effort to improve participation in the federally-funded school breakfast program and boost learning and health.

"Studies show that students who eat breakfast at school also have a better attendance rate and tend to behave better," stated King. "We're excited to work with the Partners for Breakfast in the Classroom to make a morning meal available to all students in the district."

King added, "Hunger is an obstacle to educating our youth that we hope our district can overcome. I would like to think everybody has to be onboard including cooks, Debbie and Sherry, the school board, principals, and teachers."

While most U.S. schools offer meal programs, many students do not participate in cafeteria-based school breakfast programs because of bus schedules, late arrivals to school, pressure to go directly to class or reluctance to be labeled as low income.

The BIC grant was funded by Walmart, and awarded by the Partners for Breakfast in the Classroom. WCS was awarded \$66,733.44, and the grant funding will be for a three-year cycle. Ohio Education Association is one of the sponsors of the grant.

The Partners for Breakfast in the Classroom selected districts from 10 states to participate in the program based on need and potential for success. The other states participating in the program are Idaho, Louisiana, Mississippi, Missouri, Nebraska, North Carolina, Oklahoma, Texas, and Utah.

As more schools adopt the breakfast in the classroom approach, the Partners for Breakfast in the Classroom

anticipate participation in the federally-funded school breakfast program will increase, helping reduce hunger and improve educational achievement nationwide.

Additional school districts in Ohio still have the opportunity to apply for grant funds from Partners for Breakfast in the Classroom. To find out more information and how to apply, visit www.breakfastintheclassroom.org.

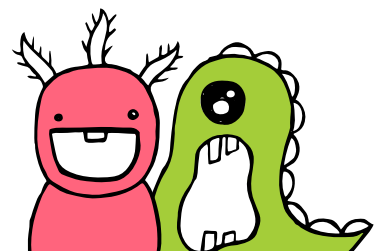

ODE Update

The Office for Child Nutrition continues to present updated and helpful information to all schools about child nutrition programs in Ohio and continues its focus on customer service. Schools should receive a response within 24 hours when asking a question about feeding Ohio's children. This article offers information about child nutrition programs, important information about procurement reviews and upcoming trainings.

Training Opportunities:

Child Nutrition Training and Vendor Show

This one-day event is set for Wednesday, Nov. 28, at the Greater Columbus Convention Center, 400 N. High St., Columbus, 43215. Attend and learn from this training designed for attendees to network, collaborate, gather and share ideas statewide.

National School Lunch Program (NSLP) Basic Training workshops are recommended for sponsor employees interested in updates about regulations and reporting procedures for school lunch, school breakfast and after school care snack programs. Attendees learn about regulations that govern the U.S. Department of Agriculture (USDA) School Nutrition Programs and how to prepare the required program reports, plan menus, approve student meal applications and other facets of operating the programs.

Visit the [Claims Reimbursement and Reporting System \(CRRS\)](#) to register or get more information for these training opportunities.

Procurement Reviews:

Local Agency Procurement Reviews are conducted every three years for each sponsor. A procurement review serves to ensure that sponsors follow and meet federal, state and local procurement rules and regulations. The sponsor must provide a listing of all vendors used for school nutrition program expenditures in the reviewed school year. From that list, ODE reviews a random selection of vendors.

The procurement review is conducted online. All required information and documentation must be uploaded into the Claims Reimbursement and Reporting System (CRRS). If ODE requests additional documentation from the sponsor,

all subsequent documentation must be uploaded into the CRRS. The sponsor can view procurement review results, findings, and/or corrective actions in the CRRS.

Child Nutrition Program Flexibilities for School Year 2018-2019:

Effective July 1, 2018, temporary revisions for milk, grain and sodium can be read [here](#). These terms cover the 2018-2019 school year.

Whole Grain-Rich and Milk Type Exemptions:

Applications for exemptions are available on the Ohio Department of Education (ODE) food waiver [webpage](#) and must be approved before the school can incorporate modifications to school meals. School Food Authorities (SFA) with a previously submitted and approved whole-grain rich exemption do not need to reapply since the waiver approval carries over to the 2018-2019 school year.

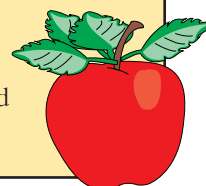

Innovation: has used innovative approaches, working practices or technologies to enhance their organization and SNA of Ohio.

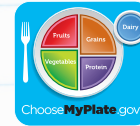
Role model: has provided an example to peers or colleagues of the importance Child Nutrition plays in the daily lives of students, staff and the community.
